- 3) Pase al Ministerio de Turismo para proseguir tramitación.

**MEMORANDUM OF UNDERSTANDING ON COOPERATION IN THE FIELD
OF TOURISM BETWEEN
THE MINISTRY OF ECONOMY AND SUSTAINABLE DEVELOPMENT OF
GEORGIA
AND THE MINISTRY OF TOURISM OF THE ORIENTAL REPUBLIC OF
URUGUAY**

The Ministry of Economy and Sustainable Development of Georgia and the Ministry of Tourism of the Oriental Republic of Uruguay (hereinafter referred to as the "Parties");

Expressing the desire to strengthen friendly relations and mutual understanding to broaden cooperation in the field of tourism,

Have reached the following understanding:

Article 1

The Parties will strengthen and develop co-operation in the field of tourism on the basis of equal and mutual benefit in accordance with the terms and conditions of this Memorandum of Understanding, national legislation and in compliance with all commitments arising from international agreements.

Article 2

The Parties will promote organized group and individual tourism between the two States.

Article 3

The Parties will facilitate establishment of contacts and development of co-operation between tourism organizations of Georgia and the Oriental Republic of Uruguay, journalists and experts specializing in the field of tourism.

The Parties will also promote establishment of cooperation between tour operators, travel agents and other relevant private tourism sector representatives of the two countries.

Article 4

The Parties will promote the exchange of journalists, photographers, travel agents and travel writers to promote tourism destination and products in each other's country.

Article 5

The Parties will exchange knowledge and best practices regarding the development of tourism related products and services in both countries.

Article 6

The Parties will exchange their tourism promotional materials and data on tourism statistics.

Article 7

The Parties will cooperate to promote investment projects in the field of tourism.

Article 8

The Provisions of this Memorandum may be changed by a mutual consent of the Parties.

Article 9

Any dispute arising from the interpretation or implementation of this Memorandum of Understanding shall be settled amicably through consultations.

Article 10

This Memorandum does not represent an international agreement and does not create any legal obligations under international law.

Article 11

1. This Memorandum will enter into force on the date of signature.
2. This Memorandum of Understanding does not create any financial obligations.
3. This Memorandum will be valid for a period of five (5) years and will be automatically extended for another subsequent period of five (5) years

unless six (6) months before the expiration date of the respective period either Party notifies the other party in writing, through diplomatic channels, of its intention to terminate this Memorandum.
